

***IOWA WILD ROOF GIVEAWAY
OFFICIAL RULES

NO PURCHASE NECESSARY. VOID WHERE PROHIBITED. PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. SWEEPSTAKES IS OPEN ONLY TO LEGAL U.S. RESIDENTS WHO ARE 18 YEARS OF AGE OR OLDER.

Participation or entry in the Sweepstakes constitutes acceptance of the terms and conditions set forth below (the “Official Rules”):
